## 1 Items to be exhibited:

Cardiovascular surgery as well as intervention medical treatment related equipment, device, system, drug, literature, and so on.

## 2 Exhibition Fee:

(One booth measures about 3.0m W x 2.0m D x 2.5m H.)

### \* Kobe International Exhibition Hall No.1

A Zone : Six booths or more **577,500 JPY/booth**

B Zone : Six booths or more **472,500 JPY/booth**

C Zone : Up to six booths **420,000 JPY/booth**

### \* Kobe International Exhibition Hall No.3

A Zone : Each booth **577,500 JPY/booth**

\* Please refer to page 4 for the shell scheme and page 5 for exhibition hall map (Image).

\* The organizer decides the booth arrangement after taking the number, shape of booths and the number of exhibitions into consideration.

Please note that applications will be accepted on a first-come, first-served basis until all spaces are filled.

## 5 How to pay the exhibition fee:

## 6 Cancellation of the exhibition:

It should be noted that you cannot cancel your application unless the organizer approves of your acceptable reason to do so, but in such a case, you will be eligible for refund of the exhibition fee. You will be charged the following cancellation fee according to the date of cancellation.

From July 1, 2012 to August 14, 2012...50%

After August 15, 2012.....80%

After October 15, 2012.....100%

**7 Basic booth specifications:**

Booths are uniformly dimensioned, consisting of system panels for rear and side walls. When two or more booths are used to form on continuous exhibition space, side partitions from neighboring booths will not be provided.

**8 Electric Supply:**

Please note that you need to apply with us separately if you need electric supply.

**9 Exhibition Date and Opening Time:**

Friday, November 2, 2012: 9:00-18:00

Saturday, November 3, 2012: 9:00-18:00

Sunday, November 4, 2012: 9:00-17:00

**10 Exhibitor move-in and move-out:**

Move-in: Thursday, November 1, 2012: All day

Move-out: Sunday, November 4, 2012: After 17:00

(Specific time of move-in and move-out will be announced in the middle of September.)

We will send you the Exhibitor's Manual for further details of exhibition, after your participation is contracted.

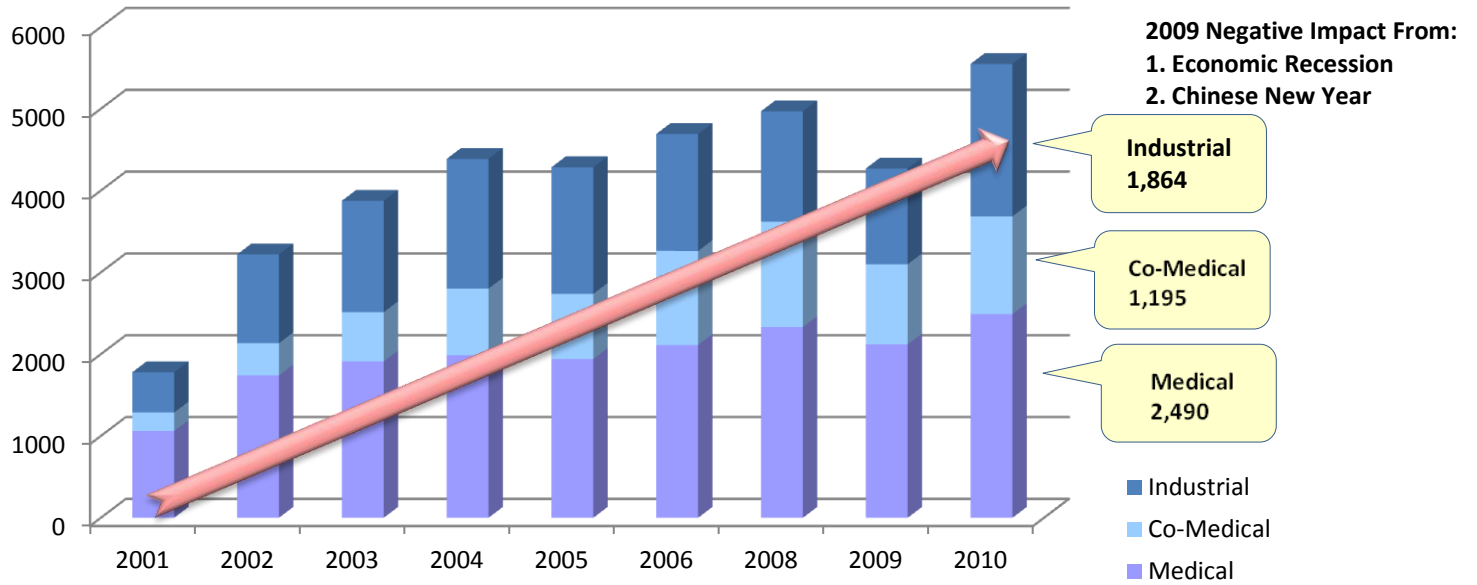
**12 Exemption from responsibility:**

The organizer may postpone or cancel the exhibition because of inevitability.

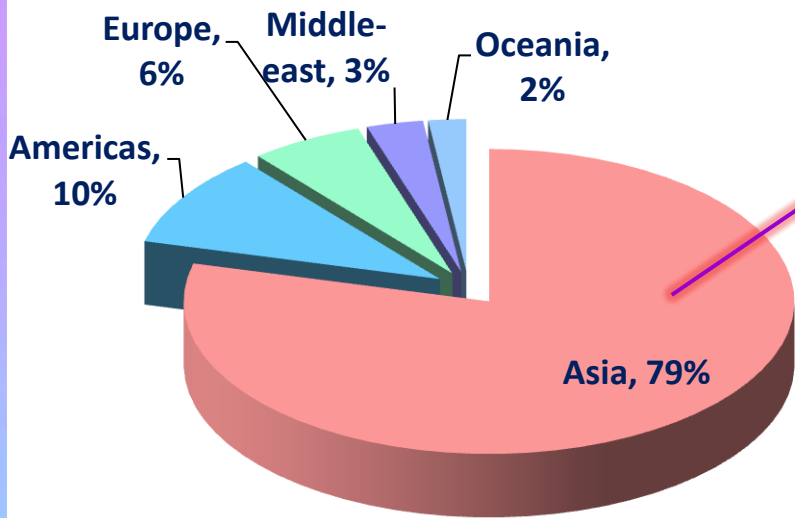
If the organizer cancels the exhibition for any reasons, you will be refunded the exhibition fee in full, but not the individual expenses accrued by preparation of the exhibition.

# CCT2010 Attendee Demographics

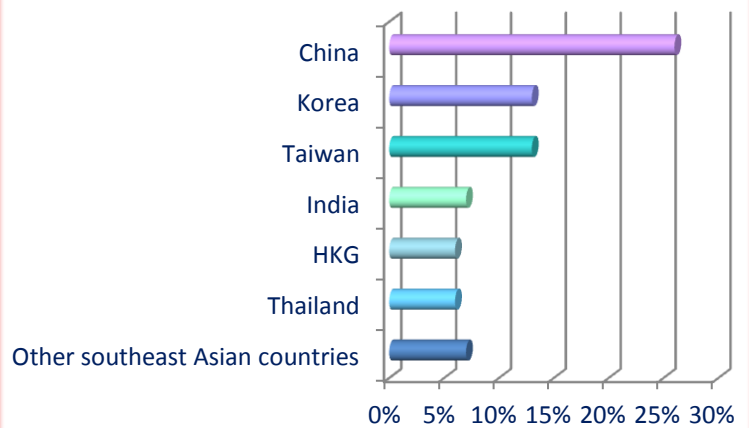
## CCT Participants in 2010
